Dave's Update:

SID Loan Relief:

- A community investment fund has been earmarked for businesses from ARPA Funds
- Once this fund is formed, businesses can apply for loan relief via an application form (SID will be able to apply for \$24,500 loan relief)

Parking Garage:

- Renovation should be done by year end
- Lot was previously permit or paid parking
- Need City to determine clear parking policy and enforce it moving forward

Heights Medical Building:

- Cornice and top piece fell and dominoed between turrets
- Turrets have all been removed. Will be replaced with fiberglass versions from casted mold
- Scaffolding to be put back up in March to install fiberglass turrets

SID Renewal:

- Will try for a 5 year renewal with the same district layout
- Look to incorporate The Ascent with the capped appraisal value that they agree to for assessment,
 based on linear feet. Owner Flaherty & Collins has done this with their Cedar Lee property
- In early 2025, draft new plan of services, budget and method of assessment to present to SID Board for approval then present to City Council
- New property values available Dec/Jan
